By submitting an on-campus housing request through the Intensive English Center Application, you acknowledge and agree to adhere to all Stony Brook University policies and expectations of Campus Residences when accepting a room assignment to live on campus.

Billing and Financial Liability

Once you submit your on-campus housing request as part of your Intensive English Center application, you have committed to your housing agreement. You may cancel your request prior to arrival. As part of the housing agreement, residents acknowledge that once they are assigned a space in campus housing and accept the key at check-in, they are financially liable for the full duration of the housing agreement, even if they subsequently choose to move out of campus housing. Arrival and Departure:

Housing Assignments and Rates

Students participating in the Intensive English Center program are housed in our corridor-style <u>first-year communities</u>. You may request a single or shared room. Additionally, you are required to have a <u>meal plan</u>.
