



Summer On-Campus Housing Acknowledgment for Students who are 16-17 Years Old

Students who are under the age of eighteen (18) are typically not eligible for on-campus summer housing as Stony Brook University Campus Residences does not provide the level of supervision that is required for a minor student. If a summer student who is sixteen (16) or seventeen (17) years old by the start of summer session 2 extended wants on-campus housing they must complete additional requirements for consideration prior to being housed. In order to be housed, the attached acknowledgment must be completed by the enrolled student and their guardian. Additionally, the student & guardian(s) must complete either an online module as part of their housing application.

Outside of the agreements on the previous page, guardian(s) need to review and discuss the following topics with their student.

- **NYS Age of Consent for Sexual Activity & Relationships:**

- The age of consent in New York State to engage in a sexual relationship/act/encounter is seventeen (17) years old. Under NYS Penal Law § 130.05, an individual under the age of seventeen is unable to provide consent for any sexual acts or activity.
- New York State does not have “close-in-age” (commonly called “Romeo and Juliet laws”) exemptions to the age of consent policy. As such, individuals who engage in sexual activity with someone under the age of seventeen (17), regardless of their age, can be charged with a crime.
- Students who are under the age of seventeen (17) should be aware of their status as a minor under the age of consent, and the fact that they are legally unable to give consent to engage in sexual activity.

- **Mandatory Reporting:**

- I have read SUNY's [Policy on Mandatory Reporting and Prevention of Child Sexual Abuse](#).
- I understand that under this policy, “[a]ny employee or student of or volunteer for the State University of New York who witnesses or has reasonable cause to suspect any sexual abuse of a child occurring on State University property or while off campus during official State University business or University-sponsored events shall have an affirmative obligation to report such conduct to the relevant University Police Department immediately.”

Additionally, I am aware that while these topics encompass some important items to discuss, it does not necessarily account for all things that should be covered between the student and the guardian(s). I understand that in order for my request to be approved, I must complete the online module OR meet with the Associate Director of Residential Education or their designee.
