

ACTUAL WAGE STATEMENT

As part of application process for H-1B employees, Stony Brook University is required to provide documentation that illustrates how the employer determines the actual wage. The actual wage is the wage rate paid by the employer to all individuals with experience and qualification similar to those of the H-1B for this specific employment. Documentation must show how the wage is set for H-1B employee related to the wage paid to other individuals with similar experience and qualifications for this position. This form is designed to assist your department in calculating and documenting actual wage. The employer is required to establish and document actual wage rate. The actual wage statement is an internal form but will be included in the Department of Labor (DOL) public access file maintained by Visa and Immigration Services. The H-1B employee should not have access to this information. This information is confidential.

SBU is required to pay the higher of the actual wage or the prevailing wage as determined by the Department of Labor.
